That dialogue will continue to happen as the id8 Downsview process evolves. The invitation and opportunity to attend and participate in the CRG meetings are offered as a means of respect and transparency with the Rights-Holders.

Role of City of Toronto staff: Role of City of Toronto staff: City Staff will act as ex-officio members of the CRG and will help inform the CRG agendas during the first half of the term focused on the City-led Community Development Plan. At other times, City staff on Update Downsview (and other City staff, as required) will be invited to every CRG meeting to support information sharing and coordination between the id8 Downsview engagement process and the City's work to update the Downsview Area Secondary Plan (560 hectares) and review OPA application jointly made by Northcrest and Canada Lands for 210 hectares in Downsview.
